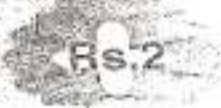

That the Government will be pleased to provide the amount necessary and sufficient to meet the cost of such work as may be necessary and convenient in such manner as the Government may think fit in the discharge of these powers and duties conferred on the said Board, subject to the following conditions:

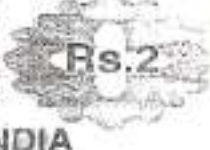
